Article 1: Hereby declares to undertake the incentive under its full responsibility, at its own risk and peril, thus irrevocably waiving for itself and all its beneficiaries, any recourse, for any reason whatsoever, against the Circuit de Spa-Francorchamps, owner of the site, as well as the aforementioned personal, company or organization insurers.

Article 2: Admits that the exemption from liability referred to in article 1 extends to employees, other participants, project managers and voluntary helpers, including for the fact of their intentional fault, except, and only as regards the employees or agents, for customers considered to be consumers within the meaning of article 1, 7. of the law of July 14, 1991 on commercial practices and on consumer information and protection.

Article 3: Accept that the exemption from liability concerns both contractual and extra-contractual liability; that it covers both physical, material or moral damage, regardless of whether said damage is unforeseeable or indirect, excluding, however, the death of the consumer within the meaning of article 1, 7. of the law of 14 July 1991 on trade practices and consumer information and protection, as well as bodily injury to them.

Article 4: Acknowledges that the exemption from liability concerns slight negligence, both accidental and habitual, as well as gross negligence except, and only in the latter case, for customers considered to be consumers within the meaning of Article 1, 7. of the law of July 14, 1991 on trade practices and on consumer information and protection.
